- Organized in accordance with the rules and regulations of ASA and EPA. All athletes indemnify the National, Provincial and Regional bodies, sponsors and organizers against all and any actions of whatsoever nature.
- Online entries are available on www.webtickets.co.za
- Collection of race numbers and late entries on Friday 10 January at Westbourne Oval,
 Westbourne Road, Central between 12h00 and 19h00, and on the morning of the race at the venue. Race number contains a chip and must not be folded.
- 5. The race committee reserves the right to accept or reject any entry.
- 6. All traffic Officials and marshals must be obeyed.
- The wearing of earphones or headsets is not permitted due to safety reasons and may lead to disqualification.
- 8. Medals will be awarded to all finishers.
- Race venue is an alcohol-free zone.
- 10. The Race will start at 06h00 at the Bluewater Bay N2 Shopping Centre.
- 11. Athletes are required to arrive well in advance due to expected traffic congestion.
- 12. The minimum age on the day of the race is 15 years.
- 13. The cut off time is at 08h30 (2hrs 30min).
- 14. Prize giving and club gazebo's will be allowed in designated area.
- 15. Prize winners must be dressed in their club colours during the award presentation.
